### TEMRS OF REFERENCE

## Consultancy for an Assessment Study on Climate-induced Resettlement Programmes

1. **Nature of the consultancy:** Advisory services to IOM and relevant government agencies of Viet Nam on environment-induced resettlement programme.

**Objective:** To perform a research study on environment-induced resettlement in Viet Nam including a literature review of successful resettlement cases and best practices within Viet Nam or in other countries, in order to inform the relevant government agencies of Viet Nam about the households' motivation to resettle, the decision-making process, and community participation in the current resettlement planning and implementation process, as well as to make recommendations for future resettlement programmes.

**Target**: Government of Viet Nam officials (the Population Relocation Unit and the Coordination Office of the New Rural Development Programme), local authorities, local communities, households affected by natural stresses/hazards.

Location: Ha Noi, with travels to research sites.

Duration: 8 months, from Aug 2015 to Mar 2016, 35 nonconsecutive working days in total

 IOM Project to which the Consultancy is contributing: "Assessment on environment-induced population resettlement design, planning and implementation and its implication for rural community development"

This assessment contributes to "Output 2.1 Recommendations on key issues, policies and strategies for new rural development" under the UN Joint Programme (UNJP) Tam Nong, and is an extension of an initial assessment conducted by IOM under the same UNJP on the impact of rural-urban migration and environment-induced resettlement programme on rural development.

The quantitative survey (500-600 households) and qualitative survey of this research study will be implemented as joint activities with another IOM's project on "Migration, Environment and Climate Change: Evidence for Policy" (MECLEP).

## 3. Tasks to be preformed under this contract:

- a. Draft a report outline based on the research study concept note outlining the research questions and submit it to IOM for review.
- b. Review and provide inputs into the sampling strategy and the existing household survey questionnaire developed by the MECLEP team in order to incorporate the data needed for the Tam Nong research study; Provide inputs into the research site selection;
- c. Develop in-depth interview/key informant interview and focus group discussion guidelines and criteria for the selection of respondents; Conduct qualitative interviews and focus group discussion in coordination with the MECLEP survey team.
- d. Perform analysis of data; Conduct a literature review of successful resettlement cases and best practices within Viet Nam or in other countries, to reflect on how the household's motivation and needs have been addressed in these specific cases. In particular, this review will strive to answer the question of to which extend climate change has been integrated into the resettlement agenda.
- e. Draft the research study report of about 40-50 pages with findings (including gender analysis) and

- recommendations; Attend consultation meeting with project's partners organized by IOM to validate the key findings; Finalize the report to incorporate comments from IOM and project's partners.
- f. Present the report findings and recommendations at a national dissemination workshop.
- g. Regularly update IOM on research progress to ensure good coordination of the project's activities. Inform IOM as soon as possible of any issue that may negatively impact on the progress of the research. Recommend solutions and implement corrective actions as validated by IOM. The Consultant will receive necessary administrative support from IOM.
